- Conduct a benefit investigation of the patient's insurance coverage for SUBLOCADE® (buprenorphine extended-release) for the patient's current site of care
- Provide information on the prior authorization and appeals process from the patient's health insurance provider
- Confirm product acquisition requirements from the patient's health insurance provider
- If applicable, determine eligibility and enroll an eligible patient for the Copay Assistance Program for SUBLOCADE, or provide alternate funding information

TRANSITION OF CARE

- Text reminders to the patient regarding their initial next injection due date or appointment with the new provider, if requested on the patient authorization
