

SUBLOCADE® (buprenorphine extended-release) ADDITIONAL SITE OF CARE (ASOC) PATHWAY

What is an ASOC administering practitioner (AP)?

An ASOC is a facility or healthcare provider (HCP), other than a prescribing physician's office, that may provide a flexible option for the administration of SUBLOCADE injections. An ASOC AP is a Drug Enforcement Administration registered practitioner who is authorized to conduct the administration of controlled substances under local, state, and federal regulations.

STEPS FOR USING AN ASOC

Prescribing Healthcare Professional

STEP 1: Locate an ASOC AP

To find an eligible AP to administer SUBLOCADE, visit the **ASOC Patient Injection Network (PIN) Locator**.

- Go to [ASOC PIN Locator](#).
- Choose SUBLOCADE Administration Site in the Select Site Type filter, enter your patient's zip code, and select your preference of AP.

Tips to identify an ASOC AP



- ☐ Offers treatment with SUBLOCADE
- ☐ Accepts patient's health insurance
- ☐ Currently accepting new patients
- ☐ Can schedule an appointment by the next injection due date

STEP 2: Prescribe SUBLOCADE

Under the selected AP, download and complete the optional referral form or send a valid prescription and indicate the AP for SUBLOCADE delivery; alternatively, the AP may require an order to inject.



Please be sure to always contact the chosen treatment provider before sending either a referral form or prescription.

WARNING: RISK OF SERIOUS HARM OR DEATH WITH INTRAVENOUS ADMINISTRATION; SUBLOCADE RISK EVALUATION AND MITIGATION STRATEGY

- **Serious harm or death could result if administered intravenously. SUBLOCADE forms a solid mass upon contact with body fluids and may cause occlusion, local tissue damage, and thrombo-embolic events, including life threatening pulmonary emboli, if administered intravenously.**
- **Because of the risk of serious harm or death that could result from intravenous self-administration, SUBLOCADE is only available through a restricted program called the SUBLOCADE REMS Program. Healthcare settings and pharmacies that order and dispense SUBLOCADE must be certified in this program and comply with the REMS requirements.**



STEP 3: Coordinate Care

The patient care remains with the prescribing HCP to continue the determined addiction treatment modality.

STEP 4: Refill Prescription

If using a pharmacy, the pharmacy will refill SUBLOCADE when appropriate and contact the prescribing HCP and the patient to coordinate the next shipment with the AP.

Alternatively, the AP may contact the patient directly to schedule the subsequent injections based on orders from the prescribing HCP.

For ASOC AP

STEP 1: Determine Preferred Procurement Method

An AP may use product procured from a pharmacy or a network specialty distributor certified in the risk evaluation and mitigation strategy (REMS).

STEP 2: Determine Coverage

If using a pharmacy, the pharmacy will determine coverage for the patient. If a prior authorization is required, the pharmacy will notify the prescribing HCP. The pharmacy will contact the patient to collect the out-of-pocket costs.

If using a specialty distributor, the AP conducts a benefit investigation to determine coverage. If a prior authorization is required, the AP will notify the prescribing HCP. The AP contacts the patient to collect the out-of-pocket costs.

STEP 3: Administer SUBLOCADE

The patient care remains with the prescribing HCP to continue the determined addiction treatment modality.
